El último de una serie de fuegos en Lawrence sucedió la noche del jueves 15 de febrero, 2008, que dejó una persona muerta y 16 residentes en busca de otro sitio donde vivir.

Cuando llegamos allí, encontramos a Thomas Joseph Madden, de 53 años, muerto en su apartamento del primer piso, situado en el 16-18 de la Calle Royal", dijo el Jefe del Departamento de Incendios Chief Peter Takvorian durante una conversación telefónica al día siguiente con Richard Aybar y Dalia Díaz durante su programa radial CrossOver que sale al aire todos los viernes de 1 a 2 de la tarde por WCCM-1110AM.

Takvorian también mencionó acerca de una explosión en el segundo piso que causó que dos de sus hombres – Tte. John Duxbury y el Bombero David Amero de la Estación 4- fueran atrapados en el tercer piso mientras buscaban a residentes de la casa que no habían sido contados. Ellos subieron al tercer piso a toda carrera, después de oír

Chief Solomon encara acusaciones de Manzi

Durante esta semana se ha venido celebrando una audiencia en el ayuntamiento de Methuen para determinar si hay causa para tomar acción disciplinaria contra el Jefe de Policía Joseph Solomon por haber malversado fondos federales y por tener conducta inapropiada a su posición. Según las reglas de Servicio Civil, él tiene derecho a esta audiencia.

Como Jefe de la Policía, Solomon es responsable de la debida administración e implementación de las dádivas para seguridad pública y de la eficaz administración y comportamiento del Departamento de Policía en general.

Solomon fue suspendido de su puesto con pago desde setiembre mientras la investigación del FBI se lleva a cabo y el Alcalde William Manzi nombró a la Capitana Katherine Lavigne Jefa Suplente de Policía.

Por varios años nuestra columnista Ellen Bahan ha estado escribiendo sobre las cosas de esa ciudad, incluyendo cuando el gobierno federal investigó el uso que le dieron a \$900,000 de fondos de Weed and Seed. Solomon, su diputado, su secretaria y una serie de oficiales estaban siendo pagados de esos fondos federales ilegalmente y dicha investigación arrojó un resultado muy negativo ya que no pudieron encontrar pruebas de que habían trabajado las horas extras que reclamaron como overtime. Ahora la ciudad tiene que devolver \$170,000 al gobierno.

Parte de la queja expuesta por el Alcalde Manzi contra el Chief Solomon dice, "Usted ha sido un fracaso en general proveyendo el liderazgo necesario para promover y mantener la moral de una entidad al cargo de la justicia."

Además del dinero que no pudieron

justificar en overtime, Manzi acusa a Solomon de utilizar a sus oficiales para asuntos familiares que no tenían nada que ver con la justicia; abusar verbalmente de sus oficiales; autorizar pagos a un comercio que beneficiaba a un miembro de su familia inmediata; consultar con abogados externos sin notificárselo al abogado municipal; de gastar \$30,000 de fondos municipales en abogados privados sin ser aprobado por el alcalde; y otras cosas más.

Por el momento, no lograron terminar la audiencia y acordaron una continuación para el 25 de marzo.

Cuando esta audiencia termine, el oficial a su cargo hará unas recomendaciones las cuales pueden ir desde un castigo hasta el despido. El Alcalde Manzi no está obligado a seguir estas recomendaciones.

Un pequeño sacrificio; una gran recompensa

Como una medida para disminuir la actividad criminal en la ciudad, Lawrence/Methuen Community Coalition (L/MCC) ha establecido el Proyecto Vecinos en Acción.

Un par de semanas atrás, los Capitanes de Cuadra de Vecinos en Acción, junto al Alcalde de Lawrence, Michael J. Sullivan y el Jefe de Policía de Lawrence John J. Romero hicieron el anuncio oficial, a la vez que colocaban una placa distintiva en un poste de alumbrado frente a las oficinas de L/MCC. De acuerdo con el Director de L/MCC Harold Magoon, durante el año pasado ellos han venido trabajando muy estrechamente con el Departamento de Policía en un detallado plan para que residentes de la comunidad se interesen en mantener sus vecindarios seguros.

El personal de L/MCC, conjuntamente con representativos del Departamento de Policía ha organizado a los residentes en caminatas por la cuadra, con líderes de la ciudad, como parte del entrenamiento de los residentes de cómo reportar actividades delictivas a través de una línea especial localizada dentro del centro de despacho del Departamento de Policía.

Desde entonces, el personal de L/MCC ha continuado colocando placas distintivas a través de distintos puntos de la ciudad, mientras está en la búsqueda de unos cuantos más capitanes de cuadra dispuestos a pasar el entrenamiento de 4 horas y unirse a este grupo cívico.

Su pequeño sacrificio tendrá una gran recompensa: ¡Paz y Tranquilidad!

In order to curb criminal activity within the city, Lawrence/Methuen Community Coalition (L/MCC) established Neighbors in Action Project. A couple of weeks ago, Neighbors in Action Block Captains were joined by Lawrence Mayor Michael J. Sullivan and Lawrence Chief of Police, John J. Romero to officially make the announcement, while placing a distinctive plaque on a lamp post across the L/MCC headquarters.

According to L/MCC Director, Harold Magoon, over the past years they have been working very closely with the Lawrence Police Department on a comprehensive plan to engage community residents in keeping their neighborhoods safe. L/MCC staff together with representatives of the Lawrence Police Department had organized residents in Neighborhood Block walks with neighborhood leaders as part of the training for area residents on the reporting of suspicious activities through a special Block Watch Hotline located within the Lawrence Police dispatch center.

Since, L/MCC staff has been placing signs in different places throughout the city while looking for a few more additional Block Captains willing to go thru the 4 hours training and join this civic group.

Una vez extendido,

esta notificación formal inicia el término de 30 días para que el distrito busque ser reconsiderado o proveer un plan enmendado y comparecer ante un Panel Estatal de Revisión.

El Superintendente Laboy y sus fanáticos en el departamento escolar siguen hablando del “progreso que han hecho”. Este superintendente ha estado al frente por siete años y nuestras escuelas están en condiciones miserables. ¡Oh, no debí usar esa palabra! Puede ofender a alguien en las Escuelas Públicas de Lawrence, pero el Departamento de Educación prueba lo contrario.

Si el estado no ve suficiente mejora en esas escuelas para junio, se convertirán en CPS como la Escuela Arlington.

¿Quiere un PhD? Venga a Lawrence

Sí, en Lawrence le resultará fácil avanzar en su trabajo.

ruidos que en ese momento les parecieron humanos. Luego fue confirmado que eran tres perros los que perecieron el incendio. "Afortunadamente nuestros hombres salieron ilesos del incidente", dijo el Chief.

De acuerdo con el Comisionado de Inspecciones Myles Burke, las ventanas y puertas del 16-18 de la Calle Royal han sido cubiertas con planchas de madera prensada así como el edificio de al lado, 10-12-14 de la misma calle, el cual necesita extensas reparaciones y limpieza antes de obtener el certificado habitacional, ya que fue seriamente dañado por el agua y el humo. "Todo este trabajo se ha hecho sin costo para la ciudad", dijo el Comisionado Burke.

Sobre la demolición que se está llevando a cabo en la Calle Andover, el Comisionado Burke dijo que como resultado de que fueron cuatro edificios que se quemaron a la vez, han tenido que lidiar con 4 propietarios y 4 compañías de seguro diferentes todas con diferentes ideas de lo que quieren hacer con sus propiedades. "El dueño del edificio de tres pisos está pagando por su demolición", dijo Burke.

"En el sitio de la Parker con la Calle Market, la ciudad puso este trabajo a subasta, la cual le fue adjudicada al postor más bajo, All State Abatement Professionals (ASAP)", dijo Burke. Como el área fue declarada como "Emergencia"

por el alcalde, la ciudad pudo circunvalar la práctica normal de subastas y adjudicar al ganador en menos de una semana. "Este proceso dura de uno a dos meses", terminó Burke.

La ciudad está administrando la limpieza del sitio completo, utilizando dinero de Community Development, aproximadamente \$150,000, los cuales serán rembolsados a la ciudad por las distintas compañías de seguro y los propietarios.

El proceso de limpieza comenzó oficialmente el miércoles, 20 de febrero, cuando la oficina del Fiscal General desestimó un reto que había sido impuesto al proceso de subastas.

Cada ciudad tiene su historia, su pasado el cual guarda el recuerdo de los momentos alegres, la tristeza, la esperanza y su lucha diaria por sobrevivir.

La prensa escrita es sin dudas el mejor archivo para preservar ese pasado con sus vicisitudes y sus triunfos.

Actualmente la Biblioteca Pública de esta ciudad, 51 Lawrence Street, cuenta con una exhibición de 60 nombres de periódicos de más de 150 años, los cuales representan el recuento de los hechos más relevantes que han impactado a esta comunidad conocida como la ciudad de Inmigrantes.

La exhibición que se llama: Hot off the press: la historia de los periódicos en la Ciudad de Lawrence, estará abierta al público hasta el mes de junio de este año.

Comenzando con el The Merrimack Courier de 1846, el primer periódico que fue publicado aquí, un año antes de que el municipio de Lawrence fuese incorporado, hasta los periódicos locales y los semanarios RUMBO y Siglo 21.

La exhibición consta de fotografías de otros tabloides como: American Register, el cual fue publicado por Know-Nothing Party, Weekly Messenger y dos periódicos en Francés: Le Progress del 1890 y los periódicos Italianos La Difesa y Il Risveglio.

La muestra incluye además el Anzeiger Und Poft, impreso en la antigua escritura Gótica Alemana, que fue publicado el 26 de abril de 1924.

En la exposición aparecen dos periódicos árabes: Al-Wafa y Al Fajr, ambos medios fueron publicados por cristianos quienes emigraron de Siria y el Líbano.

Sin importar el idioma, el año en que fue publicado o la línea que seguía el medio informativo, cada uno de los periódicos que forman parte de esta interesante exhibición representa el crecimiento y el desarrollo de esta comunidad, que está fundamentada en la presencia de los inmigrantes.







Hace unas semanas publicó usted en su periódico un comentario estableciendo un hecho que indirectamente es cierto pero, enfocado desde su punto de vista, suena duro.

Este comentario decía que yo, Jasmín García-Escoto era la vocera de Laboy. Todo el que aquí me conoce sabe que llevo ocho años trabajando para el sistema escolar público de Lawrence y en mi nueva posición en el departamento de transportación tengo el deber de comunicar a la comunidad las informaciones que se producen en este departamento y que son necesarias dar al público. Por lo tanto, sí soy vocera del Dr. Laboy, ya que de él emanen las directrices e instrucciones que yo, como su empleada, debo seguir. Afortunadamente, yo soy graduada de locución en mi país, la República Dominicana, lo cual me provee de las calificaciones necesarias para desempeñar mejor este trabajo. Esto lo digo por si surgiese alguna duda en cuanto a mi capacidad para desempeñar dicha función.

Yo sé que en su artículo/comentario no se refería a nada relacionado con el departamento de transportación, sino a un conflicto que se presentó entre dos entrenadores deportivos de la escuela secundaria y sobre el cual yo respondí unas preguntas a un reportero de un canal de televisión. Pero, como usted no se preocupó en llamarme para preguntarme nada al respecto, sino que decidió dar una opinión que no es fiel reflejo de la verdad, yo no me voy a molestar en explicarle nada sobre ese punto específicamente. Sin embargo, sí quisiera darle mi humilde opinión sobre lo que, basada en su comportamiento, he llegado a pensar de usted y su periódico.

Este pasado diciembre se cumplieron veinte años de mi llegada a esta ciudad y desde entonces hasta la fecha he sido una gran y fiel admiradora de todos los latinos que emigran a este país y que con mucho trabajo logran, no sólo abrirse paso, sino descolgar y ganarse una posición pública desde la cual pueden y ciertamente dan brillo a nuestras culturas.

Este fue mi caso con usted Doña Dalia. A pesar de que nunca hemos desarrollado una relación más allá de lo cordial y profesional, la he visto como una mujer batalladora que a base de mucho esfuerzo ha logrado sembrar su periódico en toda el área y mantenerlo en auge a pesar de las críticas y negativismo.

Pero, y este es un gran pero, desde hace unos años he visto como su objetividad, profesionalismo e imparcialidad se han visto afectados y mermados drásticamente, hasta el grado, desde mi humilde punto de vista, de perder el foco y el realismo.

No es un secreto para nadie el deterioro de las relaciones entre usted y el Dr. Laboy, lo que ha causado que la distribución de su periódico haya sido prohibida en todos los planteles escolares de la ciudad de Lawrence. Yo creo que esto nunca debió suceder, que, como diría mi mamá, "la sangre no debió llegar hasta el río", queriendo decir que las cosas nunca debieron llegar hasta ahí. Pero mi deseo

no es juzgar ni señalar culpables, pues cada quién tiene su porción de responsabilidad aquí, sino de evaluar su función como periodista, como administradora de uno de los medios de prensa más importantes de nuestra comunidad latina.

Algo que yo aprendí hace mucho tiempo y que me fue reforzado en mis clases de locución y comunicación social, es que una persona que realiza su trabajo tiene (subrayado y en mayúsculas) que procurar ser claro, imparcial, objetivo y lo más justo posible al momento de proveer información a sus lectores. De no hacerlo así, se convierte en un comunicador ineficiente y amañado, que se aparta de la verdad, lo que provoca que pierda credibilidad ante la opinión de lectores pensantes y de criterio serio.

Poniendo a un lado los problemas que en un principio crearon su hoy tan fuerte animadversión hacia el Dr. Laboy, en su afán por dañarle a él, lamentablemente, usted se ha olvidado de todos los demás seres humanos que trabajamos para las escuelas públicas de Lawrence. Usted, y utilizando el argot popular, no le ha dado mente a los miles de personas que de una forma u otra estamos ligados a este sistema, para dar rienda suelta a su ira y frustración. Para nada ha pensado en los padres y estudiantes que se ven directamente afectados con sus comentarios negativos en detrimento de los maestros y las escuelas que sirven a sus hijos. ¿Cómo cree usted que ellos se sienten al enterarse de todo lo que usted escribe acerca de las escuelas?

Up to \$40k in grant funding available for storefront improvements to Broadway and Essex Street merchants.

The Storefront Improvement Program assists Essex Street and Broadway businesses by restoring and enhancing storefront facades to their original architectural designs, taking into account merchandising needs of the business owner to provide an increase in foot traffic.

Up to \$40k in grant funds are available for each approved applicant, with 25% of the cost paid by the approved applicant. Both building owners and lesers of storefronts are eligible to apply for the program which is funded by the U.S. Department of Housing and Urban Development (HUD). 100% of architectural design fees are paid by the Community Development Department for approved applications. These funds are not taken from the grant funding.

Currently, the Community Development Department has completed seven storefronts on Essex Street and has six storefronts undergoing a new look on Broadway and Essex Street.



Lawrence's most recent fire and clean-up efforts on previous ones

The last of a series of fires in Lawrence happened Thursday night, February 15, 2008, leaving one person dead and 16 others looking for another place to live.

"When we arrived there, we found Thomas Joseph Madden, 53, dead on his first floor apartment at 16-18 Royal St.", said next day Fire Chief Peter Takvorian during a telephone conversation with Richard Aybar and Dalia Diaz during their CrossOver show which airs every Friday on WCCM-1110AM between 1:00 and 2:00 PM.

Takvorian also mentioned an explosion on the second floor that caused two of his men – Lt. John Duxbury and Firefighter David Amero of Ladder 4- to become trapped on the third floor when looking for unaccounted residents of the dwelling. They rushed to the third floor after hearing noises that at the moment it was unclear if it were those of humans. It was later confirmed that the noises were coming from three dogs that perished in the fire. "Fortunately our men got out safely," said the Chief.

According to Inspectional Services Commissioner Myles Burke, 16-18 Royal St. has been boarded up by the owner and also the building next door, 10-12-14 Royal St. needs extensive clean-up before getting their certificate of occupancy, since it was heavily damaged by water and smoke. "All this work was done at no cost to the city," said Commissioner Burke.

On the Andover Street demolition going on, Commissioner Burke said, "that site is a result of four buildings going up on fire at the same time, with 4 owners and 4 insurance companies, all closely working with the city, but with different ideas of what they (the owners) want to do with their property. "The owner of the three stories building is paying for its demolition," said Burke.

"On the Parker and Market Streets site, the city put this work out to bid, and it was awarded to the lowest bidder, All State Abatement Professionals (ASAP)", said Burke. Because the area was declared as

an "Emergency" by the mayor, the city was able to waive the normal bidding practices, therefore selecting the winning bidder in about one week's time. "This process normally takes one to two months," ended Burke.

The city is managing the cleaning of the whole site, using moneys from Community Development, approximately \$150,000, which will be reimbursed by the different insurance companies and property owners. The cleaning process officially started on Wednesday, February 20 when a challenge of the bidding process was dismissed at the state's Attorney General's office.



Once issued, this formal notification

initiates the 30-day timeframe for the district to seek reconsideration or to provide an improvement plan and appear before a State Review Panel.

Superintendent Laboy and his fanatics in the school department keep talking about "the progress they have made." This superintendent has been in charge for seven years and our schools are in miserable conditions. Oh, I shouldn't have used that word; it might offend somebody at LPS, but the Department of Education proves otherwise.

If the state does not see sufficient improvement in those schools by June, they will become CPS like the Arlington School.


Want a PhD? Come to Lawrence

Mayor Manzi Calls for Emergency Management Volunteers

Methuen's Department of Emergency Management is looking for volunteers for their Community Emergency Response Team (CERT) and Shelter Management Team (SMT). The CERT volunteers will be responsible to assist the City of Methuen's Department of Emergency Management throughout the city in times of disaster and emergencies. The CERT Program educates people about disaster preparedness for hazards that may impact their area, and trains them in basic disaster response skills, such as fire safety, light search and rescue, team organization, and disaster medical operations. The SMT volunteers will be responsible to staff and assist with setting up emergency shelters throughout the city in times of disaster and emergencies.

"This is a great opportunity for citizens to help their neighbors and give back to the city," Manzi said. "Often during times of crisis people look to help out where they can. We experienced this during the Mother's Day Flood of 2006. We received calls and visits from dozens of people looking to do what they could."

The Department of Emergency Management is prepared to activate an Emergency Operations Center during any major disaster to allow coordination of all support agencies to provide continuity of services to the public. It is responsible for advertisement, notification and assembly of services that are in the best interest of the citizens of the City of Methuen and to prepare and distribute information and procedures governing the same.

All candidates are advancing from Junior Black Belt to first degree black belt, Shodan. 

Rep. Tsongas Presents Check for \$392,000 to MVRTA

Federal Funding Will Help Purchase New Buses to Serve Lawrence, Andover, Haverhill and Methuen

Fifth District Congresswoman Niki Tsongas today presented a check in the amount of \$392,000 to the Merrimack Valley Regional Transit Authority which will help purchase fourteen new buses to serve residents of Lawrence, Andover, Haverhill and Methuen. Tsongas secured the funding as part of the recently enacted federal Omnibus Appropriations Act.

"Over the past several months, I heard from people throughout the Merrimack Valley about their support for efforts to make it easier to travel throughout our region," said Congresswoman Tsongas. "I was pleased to deliver these federal funds to the Merrimack Valley Regional Transit Authority today which will assist in the purchase of fourteen new buses which will help tens of thousands of Merrimack Valley residents get to and from work, school, health appointments, or many other

destinations in our communities. Greater access to public transit is particularly important to the elderly and disabled in our region."

"Two of these buses will be hybrid and clean diesel models, features which will benefit our environment and also allow the buses to get greater gas mileage, reducing their overall operating costs," Congresswoman Tsongas added.

"In addition to the outstanding transportation services provided by the Merrimack Valley Regional Transit Authority, the agency plays a significant role in major economic development projects in the Merrimack Valley such as the Lawrence Gateway and Haverhill parking garage. I look forward to continue to working with Joe Costanzo and members of the MVRTA board to advance these critical initiatives," Congresswoman Tsongas concluded.

"We are very appreciative of Congresswoman Tsongas efforts on behalf of the Merrimack Valley Regional Transit

Authority," said MVRTA Administrator Joe Costanzo. "These funds will help purchase the next generation of buses for the MVRTA, which will provide regional transportation services to over 1 million miles of city, interurban, suburban, and rural communities in the region."

The Merrimack Valley Regional Transit Authority (MVRTA) serves 2 million riders annually on scheduled bus routes in the northeast corner of Massachusetts. MVRTA bus service is provided in Andover, Amesbury, Haverhill, Lawrence, Merrimac, Methuen, Newburyport and North Andover. The Authority also provides service to the Robert B. Kennedy Transfer Station for connections with the Lowell Regional Transit Authority. The MVRTA also provides a Commuter Bus service to and from Boston on weekdays. Funding for the purchase of the buses will also be aided by formula funding that MVRTA is provided annually by the Department of Transportation.

about School Committeeman Jorge González and most recently as a City Councilor.

As a member of the School Committee he was nothing but a rubber stamp for Superintendent Laboy and in the City Council he is playing politics in the worst way. I paid him a compliment last October when I said that he has mayoral conditions by comparing him to Michael Sullivan. When Mike was on the council, he was the quiet one who did not contribute much to discussions and Jorge is the same way. When he calls me on the Spanish radio shows he quickly identifies himself as "the Mute."

Meanwhile, he managed to get his wife a job in the school department, his two daughters are teaching there and now, his son became a police officer.

He no longer cares if a movement is created to remove him from office or if he is never reelected again to anything. His family is all set!

DPW employees are furious!

"The city has reversed 20 years." That reaction has to do with 96 Nextel telephones that went dead a couple Sundays ago. On Monday morning, there was no way for anyone to communicate unless they used a telephone like... 20 years ago.

Well, this was a cost-cutting measure to save the city \$50,000 each year that DPW Director Frank McCann was aware of but did not tell anyone. It's all a power trip!

Now, only 18 telephones will be issued to managers, supervisors and water meter readers. This action will also serve to force the supervisors to stay with their crews while they work instead of being found in restaurants by Rumbo's camera. Remember?

City Clerk Office Hours

During the past couple of weeks we received several calls of Lawrencians complaining that the City Clerk's office is closed at lunch time when it is probably their busiest time, considering that many people would use their own lunch hour to run errands to City Hall.

I called City Clerk Bill Maloney and he explained that during the recent lay offs in Lawrence, his office lost three employees for which they now find it difficult to continue performing at the same level of service.

Mr. Maloney told me they have opted for closing the office for one hour during their lunch hour instead of staggering the breaks because he might not be able to promise that it would happen on a steady basis. It depends on whether his staff is all there, if they are not performing some duty that takes them away from the office or out sick. Those situations would force him to close some days and that will be more of a reason for complain than if he makes it a general practice until the personnel is restored and the public can continue going at the most convenient time for working people.

Tech Prep Success Focus of National Article

It's no secret that most jobs in today's highly technical workplace require an education beyond high school.

The success of a local program, designed to provide high school juniors and seniors with college preparation for technical careers, was recently featured in a national publication, Council for Resource Development.

The article explains how Tech Prep at Northern Essex Community College is designed to enhance student success in a global economy with advancing technologies. Tech Prep focuses on career exploration as well as seamless transitions to postsecondary programs.

"Tech Prep students graduate from high school with college credits and having had exposure to careers," says Gerri Grgenti, Tech Prep coordinator at Northern Essex. "Our goal is to encourage them to continue their education in preparation for high demand occupations in technology, health care, education and business."

Tech Prep students earn college credits for certain courses that are taught at their high schools, according to Northern Essex guidelines.

Northern Essex currently holds more than 70 articulation agreements with area high schools. College credit is awarded to students who meet the agreement criteria, which is usually a minimum of a B grade. The Tech Prep program, which is federally funded and administered locally by the Merrimack Valley Occupational and Tech Prep Educators Collaborative (MVOTEC), saves high school students both time and money while providing them with a strong incentive to continue their education.

This year, NECC developed an innovative 18-credit agreement in robotics and telecommunications with Whittier

Regional Vocational Technical High. It is the first of its kind in Massachusetts. This collaborative effort, according to Grgenti, demonstrates what can be achieved when college and high schools faculties work together for the good of the students.

Once enrolled in Tech Prep, students have the opportunity to participate in college visits targeting high school pathways. Each visit offers students a comprehensive event focusing on interactive classroom activities and presentations from different college offices. The idea is to provide students with extensive resources and information about NECC as well as their own career paths.

Tech Prep students also have the opportunity for career exploration through the Tech Prep Ambassador Program which involves students in events at NECC as well as career fairs at local high schools. By developing their leadership skills, students enhance their employability.

In their junior year of high school, Tech Prep students are administered the Accuplacer Test which identifies any areas of academic weakness. The students are advised to enroll in classes that address these deficiencies.

Local high schools participating in Prep Tech include Chelmsford High School, Greater Lawrence Technical School, Greater Lowell Regional Vocational Technical School, Lowell High School, Minuteman Regional High School, Nashoba Valley Technical High School, Newburyport High School, Shawsheen Valley Technical High School, and Whittier Regional Vocational Technical High School.



A few weeks ago, you published a comment in your paper stating a fact that indirectly is true, but seen from your point of view, sounds harsh.

This comment said that I, Jasmin García-Escoto, am Wilfredo Laboy's spokesperson. Everyone who knows me knows that I have been working for eight years for the Lawrence Public Schools and in my new position in the transportation department, I have the duty to bring to the community the news that are produced in this department and that need to be given to the people. Thus, I am, indeed, Dr. Laboy's spokesperson since all directions and instructions that I ought to follow as his employee come directly from him. Fortunately, I have a degree in broadcasting from my country, the Dominican Republic, which provides me with the necessary qualifications to appropriately perform this job. This is said just in case any doubt may arise about my capacity to perform such functions.

I know that in your article/comment you were not referring to anything related to the transportation department, but to a conflict that occurred between two sport coaches from Lawrence High School and about which I answered some questions to a reporter from a TV channel. However, because you did not worry in calling me to ask me any questions about this issue and instead decided to give an opinion that was not a true reflection of the truth, I am not going to bother explaining to you anything about this specific issue. Nevertheless, I would like to give you my humble opinion about what I have come to think about you and your paper based on your behavior.

This past December, I completed twenty years living in this city and since then I have been a great and faithful admirer of all Latinos that immigrate to this country and through hard work not only open paths, but excel and win public positions from where they can, and certainly do make our cultures shine.

This was my situation with you, Mrs. Dalia. Despite the fact that we have never had a relationship beyond a polite and professional one, I have seen you as a strong woman who with great effort has established her newspaper in all this area and has kept it running despite criticism and negativity.

But, and this is a big but, during the last years I have seen your objectivity, professionalism, and impartiality being affected and drastically diminished to the point, from my humble point of view, of losing focus and realism.

It is not a secret for anyone the deterioration of the relationship between you and Dr. Laboy, which has caused your newspaper to be banned from every building of the Lawrence Public Schools. I believe that this shouldn't have happened, that, as my mother would say, "the blood shouldn't have gotten to the river", meaning that things shouldn't have gotten that far. But my wish is not to judge or point out guilty

ones because everyone has a portion of responsibility here. I am evaluating your job as a journalist, as the administrator of one of the most important newspapers of our Latin community.

Something that I learned long time ago and that was reinforced to me during my broadcasting and social communication classes, is that someone who does your job has (underlined and in capital letters) to seek to be clear, impartial, objective, and as fair as possible when providing information to readers. By doing the opposite, he/she becomes an inefficient, tricky communicator that separates him/herself from the truth, which provokes losing credibility among thinking readers who have an honest discernment.

Putting aside the problems that in the beginning created the strong enmity you have today towards Dr. Laboy, in your eagerness for hurting him, unfortunately, you have forgotten all the other human beings who work for the Lawrence Public Schools. You have not cared for the thousands of people who in one way or the other are linked to this system, to let loose your anger and frustration. In no way have you thought about parents and students that are directly affected by your negative comments with detriment to teachers and schools that serve the children. How do you think parents feel knowing all that you write about the schools? Sadly, most of them can do nothing to provide their children with another type of education, and just have to conform themselves to send them to these schools, which, from your point of view, are far from offering the appropriate service their children need, and only because they are administered by Dr. Laboy, your archenemy. Despite what is established by the first amendment of this country's constitution, about the freedom of speech, you have no right to sell the unilateral idea that everything under the umbrella of the public school system of the city of Lawrence is bad. Don't forget that your rights end where mine begin and the Latin community of the city of Lawrence (and surrounding neighbors) has the right to receive information as objective and fair as possible. It is true that not everything here is running well, but it is simply impossible that there is absolutely nothing positive for you to write about to benefit, mainly, parents and students.

I want to make clear that I am not implying that this is the best school system ever, or that it is functioning at its best. No. Numbers are there; the results from local and state evaluations are there and cannot be ignored. But there has been a palpable improvement which you don't accept nor reveal to the public. To you, everything related to the school system in Lawrence is bad and smells bad.

What do you leave to the hundreds of teachers that honestly love our children and work day by day to give them the best service that the economic possibilities

I remember that a few years ago Laboy told everyone at the school department that no one was authorized to speak to a member of the press. I guess she must be Laboy's spokesperson.

allow? How can you ignore the administrative staff that also day by day performs a commendable job which contributes to the efficient development of a school day?

In your vengeance against Dr. Laboy you have definitely lost objectivity, and above all, consideration for humans. Your heart has turned hard and cold and you have lost sensibility and respect for the reputation of all the little ones that are also part of this big family of the public school system of the city of Lawrence.

Because of this, and with great regret, I see how you have forgotten to take one of the most basic steps in journalism: search and then verify your source of information or, merely confirm the news you are about to communicate.

In reference to the note you published about me, you acted lightly and in a totally inappropriate way, and even more far from the basic factual truth. The only thing that I am going to say on this regard is that, starting with Dr. Laboy, everyone who knows me, knows that I am not anyone's unconditional contributor. Before anything I am a Christian woman who does not compromise her principles or her moral values for anyone, nor sells her dignity at any price. I have the obligation to be an upright woman that fights day by day, moment to moment to be a better human being, not only because this is my legacy and example to my children, but because this is what God expects from me.

I will be praying for you to ask God to grant you the humility and all the love from Him you might need to straighten out your feelings and actions, and to again run your newspaper with the objectivity and impartiality you once did.

Community Invited to Sleep Awareness Week Events at NECC



Having trouble sleeping at night? You're not alone. According to the National Institute of Neurological Disorders and Stroke, over 40 million Americans a year suffer from some sort of sleep disorder.

The week of March 3-7, students in Northern Essex Community College's Sleep Technology Program—a one-year certificate program designed to train sleep lab technicians—will celebrate Sleep Awareness Week with a series of events that are free and open to the public.

Each day from noon to 1 p.m., the college will feature informational programs—many interactive—on different aspects of sleep. All programs will be held at the college's Dimitry Building which is located at 45 Franklin St. in Lawrence.

On Monday, a state trooper will present a program on drowsy driving; Tuesday, students will demonstrate a real sleep study;

Wednesday various types of equipment, including Sleep Apnea machines will be demonstrated; and Thursday will feature sleep trivia games.

The week will culminate on Friday, March 7 at noon with a lecture by Patrick Sorenson, MA, RPSGT, a published author and national expert on pediatric sleep issues, who will speak about SIDS (sudden infant death syndrome). Sorenson will report on progress being made in battling SIDS, a leading cause of death among infants. A faculty member in Northern Essex Community College's Sleep Technology Program, Sorenson has almost 20 years of clinical experience in the field of sleep disorders. He is the director of education for the Healthcare System Sleep Laboratories in the Greater Boston area and is a regular speaker at regional and national meetings of sleep and health care professionals.

NECC's Sleep Technology Certificate prepares students for a career in sleep medicine. Throughout the program students participate in classroom study, laboratory practice, and clinical experiences. Graduates of the program are qualified to take the RPSGT or Registered Polysomnography Technologist credentialing examination.

Sponsored by the National Sleep Foundation, National Sleep Awareness Week is a public education, information, and awareness campaign that coincides with the return of Daylight Saving Time, the annual "springing forward" of clocks that cause Americans to lose an hour of sleep.




