Rumbo on the Radio!

Fuego en el 65 de la Calle Park



Testigos no podían comprender porqué ni una sola gota de agua nunca salió de la manguera del Camión Escalera #4. "No hay presión", dijo el Bombero González. El Jefe Murphy dice que se necesitan 600 galones de agua por minuto para operarla y no los tenía. Frank MacCann dijo que la presión se hace con la bomba del camión. "Tal vez el problema fue que todos estaban utilizando el agua de la misma fuente".

Witnesses could not understand why a drop of water never came out of Ladder 4's hose. "No pressure", said the firemen Gonzalez. Chief Murphy said that it needs 600 gls. of water per minute to operate it and they didn't have it. Frank McCann said that the pressured is done by the pump. "Perhaps the problem was that they were all taking the water from one source."

Un incendio de cinco alarmas que se extendió rápidamente por el techo del edificio situado en la esquina de las calles Park y Saunders el pasado sábado, 26 de junio, y dejó a 50 personas sin hogar, fue causado por "el uso descuidado de un soplete de propano de plomería, utilizado para soldar la válvula de una ducha en el baño del apartamento #15, ubicado en el tercer piso", según el informe del incidente presentado por el Departamento de Bomberos de Lawrence.

Este fuego ha dejado a algunos residentes del área y a algunos funcionarios de la ciudad preocupados por la forma en que los bomberos cumplieron con sus funciones. Las emociones van de alta en algunos programas radiales en español con un oyente que dijo, "si yo fuera alcalde Lantigua despediría a todos los bomberos que quedan".

La primera foto tomada por Rumbo del fuego fue a las 7:09 de la tarde, 40 minutos después de la hora oficial de llegada (6:29 PM) del primer camión de bomberos según ha informado el departamento de bomberos. La foto fue tomada desde la esquina de Park y Bruce y muestra un camión escalera rociando el techo.

En esa esquina, el fotógrafo de Rumbo fue recibido por Héctor Cid, un residente cercano, quien señaló a una boca de incendio con una fuga de agua, culpando a los bomberos de ello. "Les llevó 25 minutos después de su llegada para comenzar a echar agua al fuego. Hablaban entre sí mientras caminaban para arriba y para abajo", dijo. Este sentimiento fue compartido por varios residentes que han llamado a Rumbo pidiendo no mencionar sus nombres.

Rumbo presentó las imágenes al Jefe Interino de Bomberos Brian Murphy, quien explicó que DPW y el Departamento de Agua son los responsables de la fijación de las bocas contra incendios. El Director de DPW, que se retiró el martes, 29 de junio, confirmó que ya se habían arreglado.

Fire at 65 Park Street

A five alarm fire that quickly spread through the roof of the building located at the corner of Park and Saunders Streets last Saturday, June 26th and left 50 people homeless, was caused by "careless use of a plumbing propane torch, used to weld a shower valve in the bathroom of apartment #15 located on the third floor," according to the incident report filed by the Lawrence Fire Department.

This fire has left area residents and some city officials concerned about the way the firefighters performed their duties. Emotions are high in some Spanish radio talk shows with a caller saying, "if I were Mayor Lantigua, I will fire all the remaining firefighters."

Rumbo's photographer's first picture of the fire was shot at 7:09PM,

Desde que cerraron las últimas fábricas en la ciudad, nuestra fuerza laboral fue dejada en limbo, con muchos viajando largas distancias para encontrar trabajo.

La noticia de que J.S.B. Industries, la casa de Muffin Town, se está expandiendo a Lawrence con la posibilidad de contratar y capacitar a 300 de nuestra fuerza de trabajo desempleada es la mejor noticia que llevamos en esta edición.

El anuncio fue hecho durante una conferencia de prensa por Jack Anderson, presidente de la compañía rodeado de su familia, mientras que junto a él estaba el Alcalde de Lawrence, William Lantigua.

Anderson admitió que no estaba pensando en Lawrence, cuando su familia empezó a buscar un lugar para ampliar su negocio. Entonces conoció a Lantigua.

Lantigua dijo que en su primer día de trabajo como alcalde, él mismo, Patrick Blanchette y Lenny Degnan comenzaron a mirar entre las empresas que por alguna razón u otra, querían salirse de donde estaban o simplemente en la necesidad de expandirse, que es el caso de J.S.B. Industries.

Con la crisis de empleo que nuestro pueblo enfrenta, Lantigua dijo que no perdió el tiempo en llamadas telefónicas o correos electrónicos. "Saltamos en un coche y fuimos a hablar con ellos. ¡Y aquí estamos!"

J.S.B. Industries, con sede en Chelsea, MA, va a ampliarse en el 309 de la Calle Andover en Lawrence y convertirá el edificio para funcionar como segundo centro de horneado.

"Esto es lo que la ciudad necesita en este momento", declaró el Representante Barry Finegold, presente en la conferencia de prensa, "Un inquilino que pague buenos impuestos con la capacidad para contratar y capacitar a 300 de nuestra desempleada fuerza laboral."

¡No podemos estar más de acuerdo!

This is what we need now!

Since the closing of the few last factories in the city, our labor force was left in limbo, with many traveling miles away to find work.

The news that J.S.B. Industries, the home of Muffin Town, is expanding into Lawrence with the possibility of hiring and training up to 300 of our unemployed work force is the best possible news we carry in this edition.

The announcement was made during a press conference by Jack Anderson, president of the company surrounded by his family, while standing next to Lawrence Mayor William Lantigua.

Anderson admitted that he was not thinking in Lawrence when their family started looking for a place to expand their business. Then he met Lantigua.

Mayor Lantigua said that on his first day of work as mayor, himself, Patrick Blanchette and Lenny Degnan started looking into companies that for any reason wanted to move out from where they are know or just in need to expand, which is the case with J.S.B. Industries.

With the job crisis our people are facing, Lantigua said that they didn't waste any time in phone calls or e-mails. "We jumped in a car and went to talk to them. And here we are!"

J.S.B. Industries, headquartered in Chelsea, MA, will be expanding into 309 Andover Street in Lawrence and will convert the building to operate as their second baking facility.

"This is what the city needs right now," stated Representative Barry Finegold, present at the press conference, "a good paying tenant with the capability to hire and train up to 300 of our unemployed workforce."

We could not agree more!

Desde Mi Esquina

¡No hay excusa!

En la industria de la televisión, cuando los índices han bajado, la gerencia cambia el escenario. Si la situación es muy mala, cambian a los personajes principales. Mientras tanto, el corazón de la operación se mantiene con los mismos reporteros en la calle, escritores y editores. ¿Por qué han de mejorar?

Una situación similar ocurre en las Escuelas Públicas de Lawrence. Wilfredo Laboy abusó y mal obró en este sistema escolar por los últimos diez años. El dinero se gastaba de forma inapropiada en la compra de la imprenta, la impresión de literatura de campaña, los menús de Sal's Pizza, software espía, un chofer, niñeras y abogados. Ahora los niños, padres y maestros tienen la culpa.

¡A culpar a los niños! ¡A culpar a los padres! ¡A culpar a los maestros!

Creo que esta decisión no hace más que chivos expiatorios a un personal seleccionado, que son, en general, las víctimas inocentes. La Escuela Arlington y la South Lawrence East Middle School han sido mal administradas y escasas de fondos durante muchos años. En lugar de lidiar con estos problemas, el departamento escolar ha mirado hacia otro lado y ahora ha encontrado una manera cómoda de echar la culpa de la decadencia de estas escuelas cayendo en estado de bajo rendimiento.

Cuando las escuelas no están produciendo los resultados adecuados, es hora de culpar a alguien y lo primero es cambiar la vestimenta y las caras. La Superintendente Bergeron debe mirar más el sistema y no a la gente en las aulas. Cuando año tras año, el sistema de evaluación global de Massachusetts (Massachusetts Comprehensive Assessment System - MCAS) no mejora, con la esperanza y la oración no funciona - algo debe ser cambiado y no es el maestro, después de todo, los estudiantes cuentan con maestros diferentes cada año sin tener mejoría y estamos hablando de solamente nueve de ellos en dos escuelas. Si esos maestros son realmente incompetentes, se irán a otra escuela a hacer lo que han estado haciendo con anterioridad.

¿Qué hace pensar a la Dra. Bergeron

que un maestro deficiente o un director negligente no van a arruinar una escuela que hasta ahora funcionaba en forma adecuada al ser trasladado allí? Si un maestro que ha estado aquí durante 20 años no está haciendo un buen trabajo, tiene que ser que a él o ella no le importa lo suficiente y no debería estar aquí en absoluto. El ciclo continúa.

Ahora quieren que un grupo de "personas interesadas" formado por padres, profesores y público en general los asesore. Tienen diez años de retraso.

Una gran mayoría de los profesores de Lawrence son muy competentes y quieren hacer un buen trabajo por los niños de esta ciudad. ¡Qué les permitan hacerlo!

¡Qué tan pronto se nos olvida! ¡Qué rápidos somos para culpar!

Lantigua debe ser más inteligente

Es posible que haya estado leyendo durante los últimos años acerca de mi queja cuando los alcaldes anteriores han hecho uso de un auto de la ciudad por medio del Departamento de Policía, algo que no está previsto por la Carta Constitucional de la Ciudad. Ese auto se convierte en un beneficio del empleado que nos cuesta mucho dinero en gasolina, seguro y mantenimiento.

Hasta ahora sentíamos satisfacción al ver que William Lantigua utilizaba su propio vehículo desde que asumió el cargo hasta el pasado martes cuando se presentó a la conferencia de prensa de J.S.B. Cambios en la ley de reuniones abiertas

La Legislatura aprobó una ley que exige que los municipios publiquen un aviso de la reunión durante la semana antes de las 3 PM y al menos 48 horas antes de una reunión. Las notificaciones deben ser puestas en un edificio donde se encuentren las oficinas del escribano de la ciudad o en cualquier otro edificio municipal, siempre y cuando la ciudad o pueblo le de publicidad a las reuniones a través de un método adicional, como los sitios web, periódicos locales y la televisión de cable local.

Otro requisito es que todos los oficiales electos y nombrados firmen que entienden la Ley de Ética y la Ley de Reunión Abierta. También deben tomar un curso de ética en línea cada dos años. Diga que es una manía mía, pero me gusta hacer las cosas de la manera correcta. Desde hace un par de años, he estado teniendo conversaciones con el Escribano de Lawrence William Maloney acerca de la necesidad de colocar la tablilla de anuncios acristalado que está en su oficina, afuera en el vestíbulo, donde el público pueda revisar sus anuncios después de 4:30 PM. Bueno, usted tiene que seguir dependiendo de Rumbo para mantenerse informado sobre lo que pasa en la ciudad.





40 minutes after the official time of arrival (6:29PM) of the first fire truck arrival as reported by the fire department. The photo was taken from the corner of Park and Bruce streets and shows a ladder truck dousing the roof.

In that corner, Rumbo's photographer was greeted by Hector Cid, a nearby resident who pointed out a leaking hydrant, blaming the firefighters. "It took 25 minutes after their arrival to start pouring water into the fire. They were talking to each other and walking around," he said. This sentiment was shared by several residents who called Rumbo asking for anonymity.

Rumbo presented the pictures to Acting Fire Chief Brian Murphy who explained, that DPW and the Water Department are the ones responsible for fixing the hydrants. Frank McCann, DPW director until June 29th, confirmed that it had been fixed.

Chief Murphy, on a map that shows the location of every hydrant in the city, pointed to the exact location each of the neighboring city trucks who came in our help were placed: "2,000 feet from the fire, working on relay, Dracut was connected to a Maple and Short hydrant; Salem, NH to a Bruce and Avon Street hydrant; Middleton, to Park and Bruce Street, while the North Andover apparatus went to Lawrence and Park Street, 600 feet away for water," said

Murphy and added, "We went to a Berkeley and Montgomery Streets looking for a good hydrant and it failed."

By the time this edition is circulating, thirty-two additional firefighters are being laid off. Leonard Degnan, Mayor Lantigua's Chief of Staff has said that without additional funding or union concessions, money isn't available to avoid the layoffs.

Chief Murphy who has blamed that lack of manpower and low water pressure hampered their efforts to fight the fire, reiterated his opinion. "The situation is bad now with two fire houses closed and with more lay-offs it will turn critical," ended Murphy.

Leonard Degnan, Mayor Lantigua's Chief of Staff confirmed that following instructions of the mayor, who has received several complaints about the handling of Saturday's fire by the Fire Department, he has opened an investigation into water pressure problems, firefighters attendance records, along with fire radio transmissions from the weekend.

Phone calls made to Nelson Cabrera, owner of the building located at 65 Park Street and City Building Inspector Greg Arvanitis, were not returned.

Por varios años ya, en mi esfuerzo por proveer un lugar donde pueda apoyar un área de nuestras vidas que es incapaz de hablar por sí misma pero que necesita amparo, los asuntos ambientales se han convertido en una parte muy importante de mi labor de escritor y mi filosofía personal. Con ese propósito en mente obtuve los derechos exclusivos de usar el dominio de Internet conocido con el nombre de www.earthsurviving.org (www.tierra.sobreviviente.org en español) que se convirtió y todavía se publica en un sitio de Web y donde he divulgado varios artículos ambientales a través del tiempo. Algunos de esos artículos han aparecido en otros sitios de Web también.

Cuando yo no tenía más de diez años de edad, mi familia acostumbraba pasar los veranos en una playa localizada al oeste de La Habana, Cuba, y conocida por el nombre musical de Baracoa, que no se confunda o relacione por mis lectores con otra ciudad de nombre indígena idéntico en la provincia más oriental de Cuba y, sí, llamada Oriente. Yo he escrito anteriormente artículos sobre mis experiencias infantiles en Baracoa y mis lectores parecen haberlas disfrutado porque se han sentido parte de la vida simple de esas historias.

Hay numerosas memorias que vienen a mi mente relacionadas con esos años libres de preocupaciones de mi niñez en Baracoa, pero una en particular se ha quedado grabada firmemente en mi mente y viene muy apropiada para esta época. Fuimos testigos en el horizonte lejano de frecuentes imágenes de barcos que iban a la derecha o la izquierda, muchos de ellos tanques de petróleo que cargaban el precioso oro negro que en esos días todavía era abundante y, antes que los productores de petróleo se convirtieran en oligopolio, era muy barato. Pero hubo algo poco agradable que experimenté más cerca y frecuentemente: bolas de tarro de petróleo dejados caer en el mar por los barcos tanqueros y que las olas llevaban a la costa, tarro que se nos pegaba fuertemente a nuestras extremidades e

irritaba nuestras sensibles pieles cuando nadábamos cerca de la orilla,

Nunca olvidaré mientras viva esa sensación de suciedad pegajosa que tenía que ser removida con limpiadores abrasivos apestosos. Es entonces que con lástima, compasión y preocupación veo a los pelícanos, las gaviotas y otras criaturas devotas del mar que están tratando de escapar esos segmentos de tierra que se les pega a las plumas y picos y que intentan sobrevivir los derrames corrientes de petróleo en el Golfo de México sin apenas saber lo que les hirió o sin poder articular lo que sienten. Yo lo sé, he estado allí figurativamente si no literalmente, pero ellos no lo tienen que hacer. No han sido entrenados por la evolución para sobrevivir ese ataque. Eso no es lo que se quiere decir con "la reproducción o la sobrevivencia de las especies."

En mi sitio de Web tengo dibujos y cartones de osos polares, ballenas y peces que los visitantes han encontrado graciosos bajo los cuales he colocado comentarios relacionados con sus esperanzas de vivir libre del tipo de desastre del que hemos sido testigos en el Golfo de México. Desafortunadamente esos cartones ya no son graciosos. Pero es muy fácil reaccionar con ira contra el infame gigante petrolero British Petróleo (BP). Mi sitio de Web no tiene como objeto atacar a BP o a ninguna otra compañía; no entonces, no ahora; mi objetivo es el verdadero culpable en esta crisis: usted y yo, en otras palabras, todos nosotros.

Somos nosotros los que hemos jugado en esta lotería ambiental y hemos perdido porque somos incapaces, incompetentes o impacientes para encontrar alternativas de recursos energéticos que nos permitan vivir y compartir en el espacio cada vez más pequeño de este planeta. Y no es solamente sobre la raza humana de la que hablamos. Nos referimos también al resto del reino animal que es parte de la cadena biológica. Como los pájaros en mi sitio de Web dirían: "¡Je, no empujen! Hay espacio suficiente

para todos nosotros en este barco."

Es con ese fondo que repito, con pequeñas modificaciones al final, mi artículo previo sobre "La Pesadilla de Mil Dólares... Una vez penosa mas." Espero que les guste.

La historia...

Días difíciles para Lawrence

Los tiempos difíciles están en nuestro camino y no solamente para la policía y los bomberos. Los residentes de Lawrence se han estado sintiendo el pellizco en la cartera y sólo va a empeorar. No hay otra manera.

Algo que agrava la situación es la falta de comprensión que se produce. Tomándose el tiempo para entender las decisiones que se hacen, puede que no la excuse, pero al menos, lo hará más fácil de aceptar.

En una reunión con unos trabajadores del garaje del Departamento de Obras Públicas (DPW) en la Calle Auburn quedó muy claro cuán enojados están. "Hemos hecho todo lo que nos han pedido que hagamos", dijo alguien. "¡Están despidiendo a un empleado después de 35 años!"

Tantas cosas se dijeron que lo único que quedaba por hacer era visitar y hablar con Frank Bonet, el Director de Personal de la Ciudad de Lawrence, con el fin de encontrar respuestas.

El primer tema discutido con el señor Bonet fue el aumento repentino de la póliza de seguro de salud, cuando en agosto, según los empleados de DPW, la ciudad cambiará de nuevo para el seguro de GIC, que vendrá con otro aumento en las primas.

El Sr. Bonet explicó que el aumento que vieron en esta nómina se debe a un aumento de las compañías de seguros. El aumento de este año fue de un promedio de 21%. Si la ciudad no hubiese aumentado las primas tendría que encontrar 8 millones de dólares adicionales para mantener el plan actual o por lo menos otros 3 millones para mantenerlo en marcha hasta que la ciudad entre en el programa de GIC. El programa GIC no se implementará hasta noviembre momento en el que verán una reducción

en sus primas. "Habrá una reducción de costos", dijo Bonet. "Estamos trabajando con el Comité de Empleados de Personal, así como con muchas organizaciones y pronto comenzaré a comunicárselo a todos los empleados y jubilados a través de un número de canales."

Una preocupación particular es la eliminación de la posición del operador. "¿A dónde van a parar las llamadas si el despachador se ha ido?" Ellos creen que hay una cláusula de reconocimiento en el contrato para esa posición y que la posición no puede ser eliminada.

"No hay protección de la posición si existen cuestiones presupuestarias. Cada Acuerdos de Negociación Colectiva tiene una lista de posiciones que se aceptan como su posición sindical. No indica que una posición no se pueda eliminar del presupuesto. "El plan para recibir órdenes de trabajo y órdenes de los residentes es que serán recibidas en la administración central del Departamento de Obras Públicas y desde allí transmitirán las órdenes a los gerentes.

Justificando sus quejas es la reciente contratación de los trabajadores de campaña del Alcalde William Lantigua, en un momento en que otros trabajadores están siendo eliminados. Justo en el garaje de la ciudad, "el albañil que trabajaba a tiempo parcial a \$15 por hora, se le dio un puesto a tiempo completo con un aumento de \$10,000. ¿Cuántas obras de cemento crees que puede hacer en el invierno?"

Lo mismo para el nuevo supervisor en el Acueducto. Varios empleados de mucho tiempo habían solicitado ser considerados para ese ascenso, pero un seguidor de Lantigua fue contratado como Jefe Lector

de Metros y ahora sus empleados son quienes lo están entrenando.

Los trabajadores me explicaron determinadas condiciones arbitrarias bajo las cuales están trabajando y fue tan incomprendible que es fácil estar de acuerdo con ellos.

Alguien me dijo que no podía pagar su hipoteca este mes, ya que le habían descontado \$700 de su cheque el 18 de junio con el fin de cumplir con su obligación de tomar parte en el furlough. Trabajó las dos semanas antes y no recibió su salario. "¡Eso es ilegal! ¡Hay leyes que nos protegen!"

Está en lo cierto. El año no ha terminado y tienen hasta el 30 de junio para cumplir ese compromiso.

Bonet explicó que él ha estado en comunicación constante con los dirigentes sindicales asegurándose que transmiten a sus miembros cómo han de tomar esos días libres (furlough). Además, también ha enviado algunos correos electrónicos a todos los empleados de la ciudad explicándoles cómo funciona. Los Acuerdos de Negociación Colectiva tienen lenguaje que explican que cada miembro tome sus permisos de salida antes de 30 de junio del 2010. El Sr. Bonet afirmó que no es asunto de ellos tomar esos días libres, sino que la administración anterior fue negligente tomando en cuenta el sistema de nóminas de pago y al entrar en una nómina quincenal se encontró con problemas relacionados con el pago de este Año Fiscal 2010.

"No puedo permitir que nuestra cuenta de nóminas incluya los días de furlough

Tough days for Lawrence

Hard times are coming our way and not just for police and firefighters. The residents of Lawrence have been feeling the pinch in the wallet and it's only going to get worse. There's no other way.

Something that exacerbates the situation is the lack of understanding that occurs. Taking the time to understand decisions that are made, may not be excused but at least, easier to accept.

At a meeting with a few laborers at the DPW Yard on Auburn St. it was made clear how angry they are. "We have done everything we've been asked to do," someone said. "They are laying off a 35-year employee!" So many things were said that the only thing left to do was visit and speak to Frank Bonet, Personnel Director for the City of Lawrence, in order to find answers.

The first issue discussed with Mr. Bonet was the sudden increase in the health insurance policy when in August, according to DPW employees, the city will be going into the new GIC insurance, which will come with another raise in premiums.

Mr. Bonet explained that the increase they saw in this payroll is

MR. B'S SPORT STORIES

THE INTER-CITY ALL STAR GAME AUGUST 25, 1959

The Lowell Sun sponsored an All Star game that was second to none in the State. One team from the upper valley area would compete against a team from the lower valley. All participants were high school players that had graduated in June of that year. All proceeds would go to the Lowell Sun charities and the game would be played at that city's Cawley Stadium.

This game was unique as the players from both sides would spend a 9-day training camp at U Mass to get ready for this contest. A picture of the stars that played for the Lawrence side will remind the readers of the football players of those days. The Greater Lawrence teams included LHS, Haverhill High, Central Catholic, North Andover, Reading and Methuen High. For Lowell it was Lowell High, Concord, Dracut, Keith Academy, Middlesex School, Tewksbury, Wilmington, Burlington and Billerica Memorial.

The coaching staff of the Lawrence entry was the now famous Ed Buckley as the head coach. His assistant coaches were local legend Ralph Wolfendale who had the high school named after him and his son Ralph Jr. the starter at qb for this the eleventh game of this series. Also Steve Perocchi a LHS Hall of Famer and a former

3-sport great at the local school and is now retired with his wife Nancy after a great teaching and coaching career.

Mike Riccio another Hall of Famer is listed as a trainer, although I can't figure out why. It might've been "Buck's way of sneaking in an extra coach to one up his rival coach the equally great Hall of Fame coach from Lowell Ray Riddick. Lowell also had a star studded coaching staff; along with the legend Riddick were a couple of legends in their own right. Bernie Megin of Concord was the leader of the great Concord team that for years held the consecutive win record throughout the State. I think a recent Acton Boxborough team finally broke that long standing record.

Charlie Hazel was one of Tewksbury's greatest players and later coaches ever and is still revered all Redmen coaches like Bob Aylward, Mickey Sullivan now at Lowell Catholic and former hoop coach and high school principal Tony Romano. Tony is now a head hoop official for the MIAA, his son is one of the area's top official proving the apple doesn't fall far from the tree. In the first game of this series it was Lowell winning in 1949; in 1950 it was another Lowell win 31-14; in 1951 Lawrence broke into the win column 31-0; 1952 had Lowell scoring a 6-0 shutout win; and in 1953

another win 13-7. The Buckley squad won in 1954 by a score of 25-6; 1955 produced another Lowell win another shutout 12-zip.

It was the upriver team again posting a win the score this time in 1956 the score 20-6. In 1957 Lowell again posted a win by the score of 20-14. The Greater Lawrence guys came back to romp over Lowell by a score of 52-0. A big score for the locals and some feel it vindicated a 55-0 whipping the Lowell High under Riddick gave to the Lawrence High team.

This game would also feature the All Starettes, a group of 100 girls who also attended practice sessions to present a half time extravaganza for the expected huge fan turnout. They have been trained by Wilfrid Boulger. Miss Barbara Quinney will lead this group and each will receive a Lowell Sun Medallion as a reward for their long hours of practice to participate in the game.

The pre game ceremonies will feature a punting for distance contest featuring for Greater Lowell: Marshall

In the television industry, when the ratings are down, the station management changes the background on the set. If it's bad enough, they change the anchors. Meanwhile, the heart of the operation might stay the same with the same street reporters, writers and editors. Why would the ratings improve?

A similar situation is happening in the Lawrence Public Schools. Wilfredo Laboy mismanaged this school system for the last ten years. Money was inappropriately spent for the printing press, campaign literature, menus for Sal's Pizza, spy software, a driver, baby sitters and lawyers. Now the kids, parents, and teachers are to blame.

Blame the kids! Blame the parents!
Blame the teachers!

I believe that this decision serves only to scapegoat selected staff, who are, by and large, innocent victims. The Arlington School and the South Lawrence East Middle School have been mismanaged and underfunded for years. Rather than deal with these issues, the school department has looked the other way and now has found a convenient way to lay blame for the school's sliding into underperforming status.

When the schools are not performing, it's time to blame somebody and the first thing is dress it up and change the faces. Superintendent Bergeron should be looking at the system more than the people in the classrooms. When year after year the Massachusetts Comprehensive Assessment System (MCAS) doesn't improve, hoping and praying will not work – something must be changed and it's not the teacher; after all, the students have different teachers every year without marked improvement and we are only talking about nine of them in two schools. Those teachers, if they are

really incompetent, they are going to some other school to do what they have been doing previously.

What makes Dr. Bergeron think that a failing teacher or neglectful principal are not going to ruin a school that until now was performing adequately by being moved there? For several years now, in my efforts to provide a place where I can support an area of our lives that does not speak for itself but needs advocacy, environmental issues have become an important part of my writing life and personal philosophy. With that purpose in mind I obtained in 2001, yes, nine years ago, the exclusive rights to use the Internet domain name known as www.earthsurviving.org that became and still is a live Web site and where I have published several environmental articles throughout the years, the one included here further below being one of them. Some of those articles have appeared elsewhere as well.

When I was a youngster of no more than ten years of age, my family used to spend the summers in a beach located west of Havana, Cuba, and known by the musical name of Baracoa, not to be confused or related with an identical Indian name of a city located at the other most Eastern Cuban province of Oriente. I have written articles before about my childhood experiences in Baracoa and my readers seem to have enjoyed them because they felt part of the

simple life of the story.

There are many memories that come to my mind regarding those care free childhood years in Baracoa, but one is particularly intense in my mind and very appropriate these days. We used to witness in the distant horizon the shapes of ships going right and left day in and day out, many of them oil tankers that carried the precious black gold which, in those years, was still plentiful and, before the oil producers became an oligopoly, very cheap. And there was also something unpleasant we experienced much closer often: oil tar globs dropped by the tankers in the water and reaching shore, globs that would stick unyieldingly to our feet and hands and irritated our sensitive young skins as we swam near the shore.

I will never forget that sticky sensation that had to be removed with smelly unpleasant abrasive cleaners as long as I live. So it is with pity, compassion and concern that I watch pelicans, seagulls and other sea friendly creatures trying to extricate themselves from the black bits and pieces of tar that adhere to their feathers and beaks as they desperately attempt to

survive the current oil spill in the Gulf of Mexico without knowing what hit them or articulating what they feel. I know, I have been there, figuratively if not literally, but they don't have to, they have not been trained by evolution to survive that onslaught. That is not what "reproduction or survival of the fittest" is supposed to mean.

In my Web site I have drawings and cartoons of Polar Bears, whales and fish that people found funny under which I have placed comments regarding their hopes to live free from the type of disaster we are still witnessing in the Gulf of Mexico. Unfortunately those cartoons are funny no more. But it will be very easy to react with anger to the now infamous oil giant British Petroleum (BP.) My web site was not targeting BP or any other oil company, not then, not now; my target is the real culprit in this crisis: you and me, in other words all of us. It is we who have taken these environmental gambles and lost because we are unable, incapable, unwilling, or impatient to find alternative energy resources that will allow us to live and share the space in this ever shrinking planet, and it is not only the human species we are talking about, but also the rest of the animal kingdom that is part of the biological chain as well. As the birds in my Web site would say: "Hey, don't push. There is plenty of room for everybody on this boat."

It is with that background in mind that I redo, with slight modifications at the end, my previous article about The Thousand Dollar Nightmare. I hope you enjoy it still.





Management Audit of Fire Department

Mayor James J. Fiorentini today said he ask the city council to support an outside management audit of the Fire Department and to bring in an outside consultant with national experience. Fiorentini said that a management audit would look at best national practices in running fire departments, and would be similar to the management audit which he conducted of the highway department and similar to the management audit done in the police department about fifteen years ago.

"A decade ago, the problems were not in the Fire Department, they were in the police department. The city started on

the road towards straightening out the police department with a management audit, called the Cloran Report. Those same reform steps can work in the Fire Department."

Fiorentini said that the management audit was a long term means of reorganizing the department, but that short term measures were also required and would be taken.

"We need to conduct a professional management audit of the Fire Department, similar to the audit which I instituted of the highway department and similar to the management audit done in the

police department under Mayor Pelosi. A professional management audit will help us to identify if we have the correct number of management personnel. It will also help us to look at the best practices nationwide. It will help determine the proper number of fire stations and where they should be located.

A management audit and is a long-term solutions, but they are not substitutes for short-term action. We have already instituted new practices to make certain these abuses can not happen again, and more action will be taken shortly as soon as it is cleared by our attorneys."

HAVERHILL MAYOR ANNOUNCES 2010 STREET PAVING LIST

Mayor James J. Fiorentini and Public Works Director Michael Stankovich today announced a partial list of streets to be repaved in 2010. These local streets, located throughout the City, are being redone with State Chapter 90 roadway improvement funds.

"This paving list is the result of research that has been conducted on roadway conditions through the computerized Pavement Management Study as well as personal observation, with which we address the worst streets first in order to stretch our resources."

"This is not a complete list," said the Mayor. "Some inner city streets can be undertaken with Community Development Block Grant (CDBG) funds, while other roadways are the responsibility of the State, such as Route 125 and the Groveland Bridge. "If other streets can be added, they will be repaved," declared the Mayor.

The streets to be repaved this calendar year are as follows (in alphabetic order):

- o South Elm Street (South Main Street to South Prospect Street)
- o State Street
- o Thornton Avenue
- o Valley view Avenue

In addition, sidewalk and pedestrian improvements are scheduled for Bethany Avenue near Central Plaza with Chapter 90 funds as well.

The City receives about \$1.1 million for local highway projects from the Commonwealth of Massachusetts, obtained by the City's legislative delegation.

I am running because, in the middle of this fiscal crisis, our representative and

his colleagues voted to send \$35 million to Lawrence without demanding the strictest oversight.

I am running because, even with their super majority in the House (143-16), these fiscal geniuses found it necessary to hold a special election to fill the seat formerly held by Lawrence Mayor William Lantigua. This 'special election' to put a man in office for only six months cost the city and state \$120,000.

They chose to spend the \$120,000 to seat another Democrat for six months rather than pay two additional firemen for twelve months.

Finally, after my decision to run was made, the incumbent and his fellow Democrats voted against the Massachusetts Security and Immigration Compliance Act. Their "no" vote (not one Republican voted no), effectively killed a bill that would

Another requirement is that all elected and appointed officials sign off that they understand the Ethics Law and Open Meeting Law. They must also take an online ethics course every two years.

Call it a pet peeve of mine but I like things done the right way. For a couple of years now, I've been having conversations with Lawrence City Clerk William Maloney about the need to place the glass-enclosed bulletin board in his office, outside in the lobby where the public could review its postings after 4:30 PM. He was agreeable but it was necessary to postpone its move until the interior restoration of City Hall was complete.

Well, July 1st is here, which is the deadline for cities and towns to implement changes to the Open Meeting Law. They must come up with ways to make more accessible all notices about meetings and agendas to the general public. We have a website that is terribly underused and Channel 22 (the Government Access Channel) was supposed to have been upgraded but it has been held back with the problems in the IT Department.

Well, you have to continue depending on Rumbo to keep you informed on city issues.

Now, if you think the above dialogue - it was not about what you expected, was it? - is fiction, think again. All you have to do is take a look at what is going on in the world today and realize that the possibility that we are going to go through real pain just to buy a gallon of gasoline to get a few more miles from our inefficient family car is not only possible but highly probable as well. The events we have been witnessing for the past few months, the crisis of the auto industry,

the recent oil spill, are evidence that support our point of view. When we first published this article in February of 2006 many folks thought it was fiction. Now the fiction is becoming more real and it is you and I who could become fictional.

Go to any supermarket or mall parking lot these days-we said then-and you find yourself surrounded by SUVs that not only block your view when you try to squeeze out of your parking space, but waste more gasoline than is needed to get from here to there, or return. But, of course, not always it is a SUV that does it. In other cases it is a truck driven by someone who probably could walk as well instead. But that is what we saw then. Recently Ford Motor Company announced a drastic reduction in SUV and truck production to accommodate for the sudden loss in consumer interest for those gas behemoths and it has retired some of their gas guzzling brand names (Mercury recently). SUVs and recreational trucks are going in the direction of "Ford Model's T," becoming dinosaurs.

But the evidence goes beyond car sizes on the parking lots or the crowded highways. Look at the daily news all over the world and our own nation and you will see how oil is seeping into every part of our lives in one way or the other. It is happening slowly, but surely. Governments that control the oil spigot are behind accusations and demonstrations about our way of life or our political or economic system on a daily basis. Whether it is Iran with its threat of nuclear expansion and its outrageous interpretation of history; Venezuela selling cheaper oil to poor inner city Americans directly and skipping our

elected governmental institutions but meddling on other folks' affairs or Middle Eastern governments manipulating the masses to arise and react against a small newspaper nobody ever knew before for publishing a senseless cartoon, oil is the new power broker.

And the high energy prices become part of almost anything we consume, things that we use or services we receive. Some airlines are now replacing First and Business class sections by charging for thirteen inches extra between some seats in coach or for the luggage we need to carry. Would flying naked be cheaper in the future? And whether it is the price of bread or milk and anything else we eat or drink, the reality is that all of those products require the use of transportation to be delivered to your friendly store and yes, transportation needs fuel as well.

Is it possible-I said then-that I will have to revisit this nightmarish story in another two years to reflect on still another doubling of energy prices? Well, what I did not anticipate was that this time the nightmare is not price related. You read the papers, the Internet, or watch television and all you see is more and more news about an oil well spill that no one can control. If it were gasoline, we could fill 30,000 automobile tanks every single day. Now, that is what some call progress.

the problems we are going through," said Medina the new board president reading from a prepared statement. "We are facing a \$45,000 deficit and we have to face it with a new vision for this organization," she said. "We are working on a plan to come out of this economic situation and today we promised that we will work 150% to get out of it. It's our pledge to our community,"

she added.

Diego Shephard, the new organization's treasurer announced that English as second language and computers classes will resume in September.

The hiring of an executive director and a secretary are among the long-term goals for the new board. Some teachers may receive a salary, while some may work

A one-hour documentary that explores the life of baseball's first Latino superstar Roberto Clemente, who was also a committed humanitarian, will be shown at the Showcase Cinema, Lawrence, on Thursday, June 24, at 7 p.m. and Thursday, July 15, at 10 a.m. These showings, which are free and open to the public, are presented by Northern Essex Community College and sponsored by the White Fund.

Titled "Roberto Clemente", this documentary delves into who Clemente was as a person as well as how issues of race, immigration, and culture have shaped the United States in the second half of the 20th century. Written, directed, and produced by independent filmmaker Bernardo Ruiz and narrated by Jimmy Smits, "Roberto Clemente" features interviews with Pulitzer Prize-winning authors David Maraniss ("Clemente") and George F. Will ("Men at Work: The Craft of Baseball"), Clemente's wife Vera, Baseball Hall of Famer Orlando Cepeda, and former teammates, to present an intimate and revealing portrait of a man whose passion and grace made him a legend.

On December 31, 1972, Roberto Clemente, a thirty-seven-year-old baseball player for the Pittsburgh Pirates, boarded a DC-7 aircraft loaded with relief supplies for survivors of a catastrophic earthquake in Managua, Nicaragua. Concerned over reports that the Nicaraguan dictatorship was misusing shipments of aid, Clemente, a native of Puerto Rico, hoped his involvement would persuade the government to distribute relief packages to the more than 300,000 people affected by the disaster. Shortly after takeoff, the overloaded aircraft disappeared over the Atlantic Ocean. Roberto Clemente's body was never recovered.

The film originally aired on PBS's American Experience, and won a 2008 NCLR ALMA Award.



due to an increase from the insurance companies. This year that increases was an average of 21%. If the City did not increase the premiums would have to find 8 million additional dollars to maintain the current plan or at least an additional 3 million to keep it going until the city enters into GIC. The GIC program will not be implemented until November at which time they will see a reduction in their premiums. "There will be a cost avoidance," said Bonet. "We are working with the Personnel Employee Committee as well as with many organizations and will soon begin communicating to all employees and retirees through a number of channels."

A particular concern is the elimination of the dispatcher's position. "Where will the calls be going if the dispatcher is gone?" They believe that there's a recognition

clause in the contract for that position and that the position cannot be eliminated.

"There is no protection of position if budgetary issues exist. Each Collective Bargaining Agreements has a list of positions that are accepted as their union position. It doesn't indicate that any one position cannot be eliminated from the budget." The plan for receiving work order and resident calls would be to receive them at the central DPW administration and relay the order to the managers.

Justifying their complaints is the recent hiring of Mayor William Lantigua's supporters at a time when workers are getting eliminated. Right at the City Yard, "the masonry guy, who was working part-time at \$15 an hour, was given a full-time position with a \$10,000 raise. How much cement work do you think he can do in the

winter?"

The same for the new supervisor in the Water Department. Several long-term employees applied for that promotion but a Lantigua supporter was hired as Head Meter Reader and now those employees are training him.

The laborers explained to me certain arbitrary conditions under which they are working and it was so incomprehensible that it became easy agreeing with them.

Someone told me that he could not pay his mortgage this month because \$700 was deducted from his June 18th check in order to fulfill his furlough obligation. He worked the full two prior weeks and he did not get paid. "That's illegal! There are laws protecting us!"

He is right. The year is not over and they have until June 30th to comply.

Bonet explained that he has been in constant communication with union leaders and making sure that they relay to their members about taking the furloughs. Additionally, he has also sent a few emails to all city employees about taking furloughs. Collective Bargaining Agreements have language in them that states that each member take their furloughs before June 30, 2010. Mr. Bonet stated that it's not an issue of them taking but that the previous administration failed to take into account the payroll system and by going into a bi-weekly payroll ran into issues associated with payment of this FY10.

"I cannot have our payroll system account for the furloughs into an FY11 budget," stated Mr. Bonet. "I feel that some employees are waiting until the very end to not take the furloughs and then wait to challenge the administration into the new FY11. They had an entire year to take 12 days and they waited until the last day – one week past the time to submit payroll time sheets."

This administration is under a lot of pressure to straighten out the finances in this city and it is the city employees and the general public who will be handling the extra work and expense.
