## March for Lawrence's Safety

On Saturday, May 7th, 2011, about 100 residents marched through Lawrence in support of our public safety departments, while chanting "Working Together, Lawrence First".

Marchers gathered at the Campagnone Common across City Hall, chose the sign they wanted to walk with, and past noon started marching up Common Street, turned right onto Union Street towards Essex Street where they walked all the way to Broadway.

At Lowell Street, they proceeded to stop before the Fire Department's

# ¡Estamos consternados!

Usted debía de sentirse igual si lee en el periódico revelaciones que afectan a su familia.

Ese es el caso que todo el mundo está hablando en estos días. Tal es el caso sobre Lorenza Ortega, secretaria en el Departamento de Recursos Humanos de la ciudad de Lawrence, manteniendo la calefacción de su apartamento ubicado en el 86 de la calle Boxford con la asistencia de combustible que recibía del programa GLCAC-LIHEAP.

Según el periódico local que le dio la noticia, Ortega gana \$45,000 al año y hasta donde sabemos, ella tiene 3 hijos que viven en su casa.

Si nos fijamos en la gráfica del programa LIHEAP de GLCAC publicado por nuestro periódico el 1 de abril de 2011, ella califica para la ayuda.

Lo que complica la cuestión es que William Lantigua, el Alcalde de Lawrence, dio esa dirección como su residencia durante su discurso sobre el Estado de la Ciudad el 3 de mayo de 2011, con lo que el ingreso total sube a \$145,000.

El Alcalde Lantigua emitió un comunicado de prensa el 11 de mayo 2011 que indica que no fue hasta que esta historia se filtró a la prensa, él estaba completamente ignorante de que cualquier ayuda fuera proporcionada a esa dirección y se disculpó por cualquier error que fuera cometido.

Lantigua dijo también que Ortega, la propietaria del condominio tomó las medidas necesarias para reembolsar el programa.

"Ahora que este asunto ha sido adecuadamente abordado, dirigiré mi enfoque a todas las cuestiones urgentes y críticas que enfrenta la ciudad", finalizó Lantigua.

Ciertamente así lo esperamos. La ciudad no puede permitirse el lujo de más noticias impactantes como esta.

## We are shocked!

And you would be shocked too, if you read in a newspaper revelations that affect your household.

That is the case everybody is talking about these days. That is the case about Lorenza Ortega, a secretary at the city's Human Resources Department in Lawrence, heating her condo located at 86 Boxford Street using fuel assistance from the GLCAC-LIHEAP program.

According to the local newspaper that broke the news, Ortega makes \$45,000 a year and as far as we know, she has 3 children living at her house.

If you look at the GLCAC- LIHEAP program chart published by our newspaper on April 1st, 2011, she qualifies for the assistance.

What complicates the matter is that William Lantigua, the Mayor of Lawrence, gave that address as his residence during the State of the City address on May 3rd, 2011, bringing the household total income to \$145,000.00.

Mayor Lantigua issued a press release on May 11, 2011 stating that not until this story was leaked to the press he was completely unaware that any assistance was being provided to that address and apologized for any mistake that were made.

Lantigua also said that Ortega, the owner of the condo took the necessary steps to reimburse the program.

"Now that this matter has been appropriately addressed, I will again turn my focus to all the pressing, critical issues facing the city," ended Lantigua.

We certainly hope so. The city cannot afford more shocking news.



# Desde Mi Esquina

## ¡Siempre algo en el ambiente!

El lanzamiento de las noticias acerca de Lorenza Ortega recibiendo asistencia de combustible ganando \$45,000 dólares ha enviado una serie de sectores de la ciudad en frenesí. Sabemos que el propósito de dicho artículo es tratar de achacar cualquier cosa vergonzosa en el Alcalde William Lantigua y mucha gente sigue esa línea de pensamiento.

Vamos a mirar con calma la historia. Nuestra edición de 1ro de abril mostró la tabla de elegibilidad según el ingreso para calificar para la asistencia de combustible. De acuerdo con esta tabla, la Sra. Ortega calificaba a juzgar por el número de niños que viven en su casa. No sabemos cuándo hizo la solicitud o cuánto tiempo el Alcalde Lantigua ha estado viviendo allí de forma permanente.

El hecho de que ella confesó al periodista que había recibido la ayuda, le dio credibilidad a su historia. ¿De qué otra forma podía haberlo confirmado? El 11 de mayo, recibí un correo electrónico del Dr. Thomas Perrault, Presidente interino de la

Junta Directiva de GLCAC afirmando que, "Debido a las leyes que rigen la privacidad y la confidencialidad, Greater Lawrence Community Action Council, Inc. no puede divulgar ninguna información concerniente a personas u hogares que solicitan o reciben asistencia federal o estatal."

Si ella no lo hubiese "confesado", la historia habría sido inútil porque no podía decir quién le avisó. Lantigua tiene enemigos por todos lados y no sería difícil para los miembros del personal o los administradores ponerse en contacto con el Tribune con esa información o decirle a algún miembro de la junta que lo hiciera. ¡Es bastante fácil!

Probablemente, devolverle el dinero a la agencia fue un error si ella cree que tenía derecho cuando lo recibió porque eso fue una admisión de culpabilidad.

Eso me llevó a pensar en toda la situación de una manera diferente. Ya que estamos hablando de fondos federales y estatales, ¿por qué tienen que mantener los nombres de los individuos o los hogares en

"privado y confidencial"? Deberíamos tener derecho a conocer quiénes son las personas necesitadas de nuestra comunidad. Podríamos ser capaces de ayudarlos más, pero también vamos a evitar el engaño que sigue.

En un trabajo anterior que tuve hace unos años, mi trabajo consistía en la preparación de los beneficiarios de asistencia para volver a entrar en la fuerza laboral, la búsqueda de servicios de guardería para sus hijos y el transporte para que pudieran ir a trabajar. Muy a menudo se negaban porque estaban trabajando por debajo de la mesa o el padre de los niños o un novio vivía con ellos y no era necesario conseguir un trabajo.

Ese tipo de comportamiento no ético y engañoso se encuentra comúnmente bajo el manto de la privacidad. Tenemos derecho a saber a quién estamos ayudando con nuestro dinero.

Una compañía puede no renovar el seguro si usted presenta un reclamo.

Una empresa puede cancelar o no renovar su póliza si las condiciones o el uso de su edificio cambia.

Si se muda de una casa a otra, debe cambiar el tipo de póliza sobre la vivienda en la que no vive. Si usted sufre una pérdida y tiene el tipo equivocado de seguro puede que no lo paguen por una pérdida.

Breakfast: An omelet with two eggs and lots of greens (spinach, kale, broccoli, green peppers, etc.) and coffee.

Desayuno: Una tortilla de dos huevos con muchas verduras (espinaca, col rizada, brócoli, pimientos verdes, etc.) y café.



Lunch and dinner should consist of beef, chicken, or fish in the amount that fits in the palm of your hand only. You may also have tuna packed in water. It should be accompanied by two vegetables and a big mixed salad with lots of water all day long.

# Vida nocturna en Lawrence

**U**n paseo por la ciudad mientras los bares y clubes están en su apogeo, es un reto para la Policía de Lawrence. Tuvimos la oportunidad de ir la noche del viernes desde las diez hasta las dos de la mañana con el Teniente Shawn Conway y el Detective Tom Cuddy y fuimos expuestos a una cultura totalmente diferente.

Para una ciudad pequeña de 6.5 millas cuadradas, Lawrence tiene más de 60 establecimientos de dispensación de alcohol. Uno podría pensar que es demasiado, pero como se ha explicado recientemente en una reunión de la Comisión de Licencias, el número de licencias debe reflejar el número de residentes. Cuando Mayra Lantigua se opuso a la concesión de una licencia a un nuevo solicitante porque ya tenemos demasiados clubes, el Presidente Richard Fielding aclaró que todavía hay licencias disponibles según la población de la ciudad y fue concedida.

Según el censo del 2010, la población de Lawrence pasó de 72,043 a 76,377 lo cual representa un incremento del 6.02%.

Parte de nuestra educación implicó aprender acerca de "clubes privados", que ni siquiera sabíamos que existían. Estos lugares sirven a la gente en la zona y rara vez son la causa de llamadas a la policía.

La prevalencia de los clubes públicos

representa un problema para la aplicación de la ley debido a la gran cantidad de clientes que vienen de fuera. "La mayoría de las detenciones son a personas de otras ciudades", nos dijo el Teniente Conway.

Entre ellos están los residentes de North Andover y Andover que vienen aquí después que sus clubes cierran los viernes a las 12:30 am. Ya que la hora de cierre en Lawrence es a las 2:00 de la mañana, llegan con un par de copas y continúan a emborracharse – lo que conduce a problemas.

"Cierra la puerta!", gritó el Teniente Conway a un hombre en Marabú con la puerta abierta. "Ustedes saben que la puerta se supone que esté cerrada. Si vuelvo y está abierta, te voy a dar una multa de \$200!" Cuando las puertas están cerradas, el ruido en el interior se hace más soportable afuera. El problema es que cada vez que pasamos por allí, la puerta estaba abierta. El Teniente Conway reconoce que la aplicación de las leyes y ordenanzas es difícil con tantos policías despedidos, aunque esta es una

situación que hemos tenido durante años en Lawrence, mucho antes de que la fuerza policial se redujera.

Recibimos una llamada a Melinda's Restaurant en Broadway. Melinda's comenzó como un pequeño restaurante y ahora es un club nocturno regular. La persona que llamó se quejó del ruido; respondieron tres carros patrullas y hablaron con el gerente en la acera, quien dijo que bajaría el volumen.

Este viernes la noche fue particularmente tranquila con un solo incidente. A medida que pasábamos por Tedeschi Convenience Store en las calles Union y Exeter, nos dimos cuenta de muchos automóviles estacionados frente a la tienda y un grupo de jóvenes afuera. El Teniente Conway predijo que no lucía nada bueno. Unos

**R**iding around while the bars and clubs are hopping, is a challenge for Lawrence Police. We had the opportunity to go along on a Friday night from ten o'clock until two in the morning with Lt. Shawn Conway and Detective Tom Cuddy and we were exposed to a whole different culture.

For a small city of 6.5 sq. miles, Lawrence has in excess of 60 alcohol dispensing establishments. One might think that it is too many but as explained recently at a meeting of the Licensing Commission, the number of licenses should reflect the number of residents. When Mayra Lantigua objected to granting a license to a new applicant because we already have too many clubs, Chairman Richard Fielding clarified that there are licenses still available according to the population of the city and it was so granted.

# Lawrence Insurance Fraud Task Force continúa su misión

Hace siete años, la Ciudad de Lawrence fue tachada de Capital del Fraude de Massachusetts con razón. Un alarmante número de accidentes de tránsito con testigos falsos sacó a la luz una "epidemia" de fraude de seguro. Las primas de seguro se dispararon, sin embargo debido a una atenuación de primas de seguro en las áreas urbanas por el entonces comisionado de seguro, las primas en Lawrence se habrían aumentado.

Afortunadamente, es cosa del pasado. Gracias a los esfuerzos concertados y coordinados por el Departamento de Policía de Lawrence, el Insurance Fraud Bureau de Massachusetts, el Essex County District Attorney, con la ayuda de la oficina del Procurador General, se han presentado cargos contra más que 400 personas por delitos de diversas formas de fraude de seguro. Desde abogados y quioprácticos, profesionales que reclutan víctimas y las "víctimas" que simulan choques de automóviles, los esfuerzos de Community Insurance Fraud Initiative Task Force (CIFI) dieron resultado.

CIFI continúa el trabajo en Lawrence a pesar de las limitaciones de recursos del Departamento de Policía de Lawrence,

debido a un resultado presupuestario que todos esperamos sea temporal.

En 2003, existió en Lawrence una industria casera de defraudadores de choques simulados, a menudo orquestada por médicos y abogados. En esa época hubo 22 clínicas de quiopráctico o fisioterapia tildadas de "clínicas de gran volumen" por la cantidad de "tratamientos" de víctimas por accidentes automovilísticos, algunos legítimos por cierto, pero muchos para lesiones inexistentes con el motivo de presentar reclamos fraudulentos. Hoy en día sólo queda una gran clínica sin acusaciones de maldad. Algunos abogados involucrados en la práctica de simular accidentes de tránsito han sido procesados. Parece que un cierto grado de normalidad ha regresado.

Los ciudadanos de Lawrence se beneficiaron. Como resultado de impedir el pago de decenas de millones de dólares en reclamos fraudulentos del sistema, las primas de seguro de vehículo han llegado a niveles más bajos que los de hace seis años. Los ciudadanos pagan al año unos \$500 menos por vehículo, un ahorro mayor del 30 por ciento que los niveles precedentes.

Desafortunadamente, con la recién

retirada de los recursos por parte del Departamento de Policía de Lawrence de las fuerzas que combaten la delincuencia en la ciudad, un puñado de malos actores han vuelto a la conducta delictiva. Esto se ve en el último incremento de vehículos reportados como robados. En el Insurance Fraud Bureau hemos visto que algunos de estos hurtos de vehículos han sido falsificados para eludir el pago de un auto o deshacerse de un auto que consume mucha gasolina, y los estamos investigando con mucho cuidado.

Esperamos que la pequeña parte de la población que causó las altas primas en el pasado no vuelva a cometer estos delitos con la teoría que nadie los está mirando. De hecho, la fuerza formada en 2003 para combatir el fraude de seguro todavía está activa y permanece en Lawrence. Todavía investigamos y procesamos los casos, y esperamos que los recursos adicionales de la policía vuelvan pronto. Mientras tanto continuamos la misión para beneficiar a los ciudadanos de la ciudad que cumplen la ley, a los que pueden llamar al 1-800-32FRAUD (1-800-323-7283) para denunciar una sospecha del fraude de seguro.

## Lawrence Insurance Fraud Task Force Continues Its Mission

Seven years ago, the city of Lawrence was justifiably labeled the Fraud Capital of Massachusetts. An epidemic of insurance fraud was exposed by a troubling number of staged accidents for profit. Insurance premiums had skyrocketed, yet due to some tempering of insurance rates in urban areas by the commissioner of insurance at the time, premiums were kept from going as high as they could have gone in Lawrence.

Gladly, that is in the past. Thanks to a concerted, coordinated effort by the Lawrence Police Department, the Insurance Fraud Bureau of Massachusetts and the Essex County District Attorney, along with assistance





## Never a dull moment!

The release of the news about Lorenza Ortega receiving fuel assistance while earning \$45,000 has sent a segment of the city into frenzy. We know that the purpose of such article is trying to pin anything embarrassing on Mayor William Lantigua and many people followed that line of thinking.

Let's calmly look into the story. Our April 1st edition showed the income eligibility table in order to qualify for fuel assistance. According to that chart, Ms. Ortega qualified judging by the number of children living in her home. We don't

know when she applied or how long Mayor Lantigua has been living there permanently.

The fact that she confessed to the reporter that she had received aid, gave credibility to his story. How else would he have been able to confirm it? On May 11, I received an email from Dr. Thomas Perrault, Acting President of GLCAC's Board of Directors stating that, "Due to laws governing privacy and confidentiality, the Greater Lawrence Community Action Council, Inc. cannot release any information concerning individuals or households

that apply for or receive federal or state assistance."

Had she not "confessed" the story would have become useless because he could not say who tipped him off. Lantigua has enemies all over the place and it would not be difficult for staff members or administrators to contact the Trib with that information or tell some board member to do it. Easy enough!

Probably refunding the agency was a mistake if she believes that she was entitled to it when it was received because that was an admission of guilt.

That prompted me to think about the whole situation in a different way. Since we are talking about federal and state funds, why do they have to keep the names of the individuals or households in "privacy and confidentiality"? We should be entitled to know who the needy people in our communities are. We might be able to help them more but we will also avoid the cheating that goes on.

At a previous job I had a few years ago, my job was preparing welfare recipients to re-enter the labor force, finding day care for their children and transportation for them to get to work. Very often they would refuse because they were working under the table or the children's father or a boyfriend was living with them and did not need to get a job.

That kind of unethical and deceitful behavior is commonly found under the cloak of privacy. We are entitled to know who is being helped with our money.

## Hispanic Week is only a month away

What? They are operating under Hispanic time again!

There have not been any notifications of upcoming fundraisers or events, something that should be taking place by now. We are closing this edition on Thursday night and I called its President Rosa Aquino twice leaving a message that is important to talk to her tonight. She has not returned my calls.

We certainly miss Brian De Peña. When he was president of Hispanic Week everything ran so smoothly! Brian was on top of the different committees and met regularly. He was also the rock behind the group of young people performing community service all over the city, all year long.

Let me predict what's going to happen with Hispanic Week this year: there will be no ad book because there is no time to sell ads and print a half-way decent book. The pageants for the different age groups will take place all during the same week, the week before it begins and the VIP luncheon will take place at the Wyndham because there is no time to plan anything. It will take three hours anyway because everyone will be looking for credit for something.

To add insult to injury one selected all star only played in one game because if you lost a game you were out. CCHS knocked this player's team out of the tourney. Most fans agreed that only playing in one game shouldn't allow a player all star status. Billy - now a retired school teacher is a part time bartender at the Lawrence Elks -scored 49 points in these games and although his team lost by 3 points, he was the straw that stirred the drinks for the local entry. It is amazing that such a performance under so much pressure would not be noticed by the selecting group.

Unfortunately, I didn't see those games

that weekend nor did I know Batey as Jack, Biff, and the late Archie McCarthy used to call him but eventually we became good friends. I swear to all the readers he has never to this day told me of the day that this group of selectors did their Jesse James impression by committing "highway robbery" in front of thousands of fans (or witnesses) at Central Catholic to soil such a great event.

Bill later played softball for me for many years and his ability to perform in the clutch helped lead our teams to more than a few league titles. His talent and friendly ways made him known throughout the state in fast pitch as every opponent knew of his abilities. Later in the year Bill is honored by the Archdiocese of Boston by the CYO organization as the youth of the year and those years he attended St. Laurence's Parish and played football, basketball and baseball for the Marist School.


This robbery in 1961 would be as famous to the local sports fans as the great Brinks robbery of the past.

El Administrador del Tribunal de Justicia también será necesario para identificar las funciones administrativas centrales y crear ahorros de costos y la eficiencia mediante la consolidación de determinadas actividades administrativas de los distintos departamentos de la Corte de Primera Instancia. El Administrador del Tribunal de Justicia también será cargado a la aplicación de un modelo de contratación y una herramienta de seguimiento de candidatos para todos los empleos en el Tribunal de Primera Instancia.

Los presidentes de los distintos departamentos de la Corte de Primera Instancia continuarán su mandato actual y se encargarán de las funciones básicas de justicia.

Las reformas de la ley también prácticas de contratación y promoción en el Departamento de Libertad Condicional, que, de acuerdo con la legislación, permanecerán en el Poder Judicial.

El proyecto de ley también añade necesaria transparencia a la contratación y promoción de prácticas a través de recomendaciones a las agencias estatales que requieren que se hagan por escrito para proteger la contratación de las autoridades hasta la ronda final de la entrevista.

Además, los solicitantes de empleo en las ramas ejecutiva, legislativa y judicial tendrán que revelar los nombres de todos los miembros de la familia inmediata que sean empleados del Estado. Esta información se hará pública de los candidatos seleccionados.

Por último, para continuar con el esfuerzo de reforma en curso en el Departamento de Libertad Condicional, el proyecto de ley establece un Consejo Asesor para ayudar a crear mejoramientos adicionales en el departamento. El consejo estará compuesto por siete miembros con experiencia en los ámbitos de la justicia, la política pública, los recursos humanos y la gestión.





# Massachusetts YouthBuild Programs Hold 15th Annual Carpentry Challenge and Service Project to Benefit Veteran's Hospitals and Clinics

**O**n May 10th, 2011, ten programs from the Massachusetts YouthBuild Coalition (MYBC) and three out of state YouthBuild programs, one from Rhode Island and two from Vermont, gathered at the Home Depot in Methuen for the 15th Annual MYBC Carpentry Challenge. The challenge was hosted by YouthBuild Lawrence, YouthBuild Lowell and the Massachusetts YouthBuild Coalition.

Teams of YouthBuild participants from each program competed in a Carpentry Challenge that tested their technical, accuracy and safety skills and allowed them to showcase the construction skills they have learned in the program. All teams were given instructions and materials to

build wood frame walls with plywood sheathing and drywall. The team from Fall River took top honors for the third year in a row. Brockton came in second followed by the team from YouthBuild Lawrence in third place.

Additional teams of students also built 10 handicapped accessible picnic tables and benches that were donated to VA hospitals in program communities as part of the Coalition's "Serving Across the State" AmeriCorps Week project. The service element of the Carpentry Challenge was funded in large part through a service mini-grant from the Massachusetts Service Alliance. This service project highlighted the Coalition's Service Learning Model

and enabled students from across the state to attend as YouthBuild and AmeriCorps members and to serve in appreciation of the men and women who have served our country.

YouthBuild offers young people between the ages of 16 and 24 a unique combination of academic instruction and workforce development training. Young people work to attain their GED or high school diploma while building affordable housing in their communities. This approach allows students to develop important workforce and academic skills while they enrich their communities. The Massachusetts YouthBuild Coalition provides resources for its member programs in the following

areas; peer support and evaluation, technical assistance, coordination of statewide events, and application for State Line Item or other sources of funding. It also facilitates cross-program collaboration and sharing of best practices.

The Massachusetts Service Alliance, Established in 1991, is a private, nonprofit organization serving as the state commission on community service and volunteerism. Its mission is to catalyze the innovation and growth of service and volunteerism by creating partnerships that maximize resources, expertise, capacity, and impact.

places cater to people in the neighborhood and seldom are the cause of police calls.

The prevalence of public clubs represents a problem for law enforcement because of the large number of patrons coming from outside. "Most arrests are to people from other cities," Lt. Conway told us.

Among the outsiders are Andover and North Andover residents who come here after their clubs close on Fridays at 12:30 a.m. Since closing time in Lawrence is 2:00 a.m., they arrive with a few drinks and continue to get drunk – leading to trouble.

While making the rounds, we noticed how the noise coming out of the clubs and bars travels for blocks. Residents at the Washington Mills apartments and St. Alfio's suffer from the noise pollution coming from Marabú and Centro every weekend.

"Close that door!" Lt. Conway yelled at a man holding Marabú's door open. "You know that door is supposed to be closed. If I come back and it's open, I'll give you a

\$200 fine!"

When the doors are shut, the inside clatter becomes more bearable outside. The problem is that every time we came by, it was the same with the door opened. Lt. Conway admitted that enforcement of current laws and ordinances is difficult with so many police officers laid off although this is a situation that we have been having for years in Lawrence, long before the police force was reduced.

There was a call to Melinda's on Broadway. Melinda's started out as a small restaurant and it is now a regular night club. The caller complained of noise; three cars responded and they spoke to the manager on the sidewalk who said that he would turn the volume down.

This Friday night was particularly quiet with only one incident. As we went by Tedeschi Convenience Store on Union and Exeter streets, we noticed many cars parked in front of the store and a group of young people standing by. Lt. Conway predicted

that they were up to no good. A few minutes later, a call came in reporting a stolen car from Tedeschi. By the time we reached the corner of Haverhill and Jackson, four other cruisers had apprehended the thief and recovered the car within 45 minutes.

"I should be a mind reader," said Lt. Conway referring to his previous comment when we went by Tedeschi and foresaw they were up to no good. That comes after years of experience.

The most interesting part of the night was how the traffic became congested after 11:00 pm around the clubs and by midnight, the towing companies were going up and down removing cars illegally parked because there was no place for them along any of the side streets. It was exciting seeing the Lawrence economy at work, after all, the bars and

clubs hire people and contribute to the city coffers. The local boutiques are kept in business by the ladies who wear the skimpy clothes we see on their windows. Yes, somebody actually wears those fashions!

The city was vibrant but the police officers were not happy about it. "It is at closing time when things happen," Detective Cuddy explained. It is after two in the morning when trouble begins and fortunately, that night was fairly calm.

Now that two of the bridges are being repaired, when the clubs are closing and traffic increases, becomes more difficult traveling between clubs when an emergency occurs.

It is clear that we need a full police force to keep the peace, prevent incidents outside of the clubs and to enforce ordinances. Perhaps another solution is closing them earlier to avoid so many potential troublemakers from other cities coming into Lawrence for last call.

## HOUSE: MA House passes Court Reorganization and Probation Reform Legislation

between the legislative and judicial branches to provide a streamlined system of justice and restore public trust in the state's Probation Department.

"This major reform legislation will improve upon an already strong court system by facilitating a more efficient and cost-effective infrastructure for the disposition of justice," House Speaker Robert A. DeLeo said. "Not only does this bill create a civilian administrator to oversee the business aspects of the Trial Court, but it also adds needed transparency to the hiring and promotion practices at the Department of Probation. By passing this reorganization bill, the House has committed to bring a more transparent, efficient system of justice to the people of Massachusetts."

"This proposal will increase accountability and improve the efficiency of our Trial Court," said Representative Eugene L. OtFlaherty, House Chairman of the Judiciary Committee. "The Speaker and the SJC worked together to provide transparency to the hiring process in our Trial Court and improve its administration. This measure will go a long way in improving confidence and morale."

"It was truly an honor to stand with my colleagues in approving this bill of paramount importance," said Representative Marcos Devers (D-Lawrence). "Our Trial Court system has been among the best in the nation and with this reorganization more transparency and accountability will reinforce its trustworthiness."

Following the recommendation of the Monan Commission Report, the bill creates an Office of Court Management and a Chief Justice of the Trial Court to divide the responsibilities currently held by the Chief Justice for Administration and Management.

The Chief Justice of the Trial Court will serve as the judicial head of the Trial Court, responsible for planning, policy, assigning judges, judicial discipline, and all other inherently judicial functions.

Under the legislation, the civilian Court Administrator will be responsible for the general administration of the Trial Court, including reviewing and approving the hiring of non-judicial employees, administering appropriations and expenditures, negotiating contracts and leases, and any other inherently non-judicial administrative functions.

The Court Administrator will also be required to identify core administrative functions and create cost-savings and efficiencies by consolidating certain administrative activities of the various departments of the Trial Court. The Court Administrator will also be charged with implementing a hiring model and applicant tracking tool for all employment within the Trial Court.

The Chief Justices of the various departments of the Trial Court will continue their current appointments and will be responsible for core judicial functions.

The bill also reforms hiring and promotion practices in the Department of Probation which, according to the legislation, will remain in the judicial branch.

An objective entrance exam will be established for the hiring and promotion of all probation and court officers. Successfully passing the exam will enable candidates to advance to the interview stage, provided that they meet all other requirements for the position.

Candidates who pass the exam and meet all other requirements will then be subject to a rigorous background review and interview process, which will be based on best practices recommended by the Harshbarger Commission on Probation

### Department Hiring

Furthermore, the bill removes unilateral hiring power from the Commissioner of Probation, instead making hiring within the Probation Department subject to the approval of the Court Administrator.

The bill also adds needed transparency to hiring and promotion practices across state agencies by requiring recommendations offered on behalf of any applicant to be made in writing and shielded from hiring authorities until the final round of the interview process.

In addition, applicants for employment within the executive, legislative, and judicial branches will have to disclose the names of all immediate family members who are state employees. This information will be made public for successful applicants.

Finally, to continue the ongoing reform effort at the Probation Department, the bill establishes an Advisory Board to help craft additional improvements within the department. The board will be comprised of seven members with expertise in the fields of criminal justice, public policy, human resources and management.

## JOHNSTON: Lawrence Insurance Fraud Task Force Continues Its Mission

from the Attorney General's office, over 400 people have been charged with various forms of insurance fraud crimes. From attorneys, to chiropractors, to runners, to staged accident "victims," the Community Insurance Fraud Initiative task force has seen its efforts pay off. This CIFI task force still operates in Lawrence today, despite the unfortunate pullback of resources by the Lawrence Police Department, a budgetary consequence we all hope is temporary.

Back in 2003, Lawrence was festering with a cottage industry of staged accident perpetrators, often orchestrated by a licensed professional medical practitioner or attorney. Indeed, back then, there were 22 chiropractic or physical therapy clinics in Lawrence that were labeled "high-volume clinics" for the unusually large number of auto accident victims they "treated" -- some legitimately, of course, but many with non-existent injuries who were used only as a means to file fraudulent claims. Today there is only one large clinic remaining, which has not been accused of wrongdoing. Several lawyers who were implicated in the staged accident schemes have been prosecuted. It seems that a degree of normalcy has returned.

And the citizens of Lawrence have benefited. As a result of taking tens of millions of dollars of fraudulent claims out of the system, car insurance premiums have come down to levels well below the subsidized levels of 6 years ago. Citizens today pay over \$500 less per car on average each year, a savings of over 30% from prior levels.

It is unfortunate that on the heels of the recent pullback of resources by the Lawrence Police Department from the various task forces that fight crime so effectively in the city, a handful of bad actors have returned to criminal behavior. This is seen in the recently reported increase in stolen cars. In the Fraud Bureau, we have seen that some of these were thefts arranged to perhaps get out of a car payment, or to unload a gas guzzler. And we are investigating those closely.

We hope that the small portion of the population that caused premiums to be so high in the past will not return to their ways, on the theory that nobody is watching. In fact, the task force that was formed in 2003 is still quite active, and will remain in Lawrence.

Cases are still being investigated and prosecuted, and we hope that additional resources from the police department will return soon. In the meantime, we carry on the mission for the benefit of the law-abiding citizens of the city, who can help by reporting suspected insurance fraud on our hotline: 1-800-32FRAUD (1-800-323-7283).


